Waterpipe Use in Ontario

As waterpipe (hookah) use has increased around the world, particularly among young people, it has become a growing public health concern. The smoke inhaled through waterpipe contains many of the same toxic constituents found in cigarette smoke, posing potential health risks to users and those who are exposed to secondhand smoke.^{1,2}

Key Finding: 30% of Ontario's young adults aged 20-24 have smoked waterpipe tobacco

This update examines the latest population survey data about the prevalence of waterpipe use in Ontario, patterns of use, the relationship of waterpipe smoking to use of other tobacco products, beliefs about potential harms, and attitudes about regulation.

Waterpipe Use among Youth

2013 Ontario Student Drug Use and Health Survey

- According to the 2013 Ontario Student Drug Use and Health Survey (students in grades 7-12), the prevalence of ever use of hookah was 11.2% (95% CI: 9.5, 13.1) with 9.7% (95% CI: 8.2, 11.5) of students reporting hookah use within the past year (see Table 1 and 2).
- 4.3% (95% CI: 3.3, 5.5) of students reported using hookah at least 6 times in the past 12 months. There were significant differences in past year use by sex and grade.
- For daily smokers 43.3% used hookah in the past year compared to 42.8% of occasional smokers and 6.3% of nonsmokers. Cigarette users, marijuana users, and alcohol users were more likely to have used hookah.
- Use of hookah was lowest in the Erie St Clair and South West LHIN and the Waterloo Wellington LHIN with 7.5% past year use. Use was highest in the Hamilton LHIN with 15.3% past year use.
- Among all students including both waterpipe users and nonusers, only 18.2% (95% CI: 16.7, 19.9) thought there was a "great risk" of using hookah regularly compared to 30% of students who perceived great risk from using 1 to 2 cigarettes daily.

2010 Youth Smoking Survey

- Using the Youth Smoking Survey data, the estimate of ever use in 2010 in Ontario youth grades 7-12 was 6.2% (95% CI: 5.3, 7.2) compared to 5.7% (95% CI: 4, 7.5) in 2006 (see Table 3 and 4). This is lower than the national average of 7.3% (95% CI: 6.4, 8.3) in 2010.
- The prevalence of hookah use increased 6% using among all Canadian students.³ Boys and students in older grades were more likely to have ever used hookah.
- Over forty per cent of current cigarette smokers had tried hookah (40.7%; 95% CI: 29.6, 51.9). Cigarette smokers, marijuana users, occasional and frequent alcohol drinkers and binge drinkers were more likely to have used hookah.
- Nondrinkers and nonmarijuana users were less likely to have used hookah compared to nonsmokers. There was no reportable difference by ethnicity. Marijuana users and males were more likely to use hookah.

Waterpipe Use among Young Adults

- The Canadian Tobacco Use Monitoring Survey captures young adult use. In 2012 in Ontario, 29.7% (95% CI: 23.3, 36.1) of young adults 20-24 had reported using waterpipe, compared to 12.9 (95% CI: 12.9, 9.5) of youth 15-19 years old.
- Young adult ever use but not youth ever use was significantly higher in 2012 than in 2011. There was no statistical difference in use by education or occupation for the Ontario data.
- While the Ontario data was not reportable, 82.9% of Canadian waterpipe users who reported use in the past 30 days said that they smoked flavoured tobacco in the waterpipe (see Table 5 for additional data).

Public Opinion about Waterpipe Use

- The CAMH Monitor, 2012 (n=3030) asks adults older than 18 about public support for waterpipe regulations. Of those who expressed an opinion, 23% supported allowing waterpipe smoking indoors and outdoors while over three quarter (77%) supported additional regulations.
- Banning use on patios and indoors was supported by 41%, while banning indoor use only was supported by an additional 36%.
